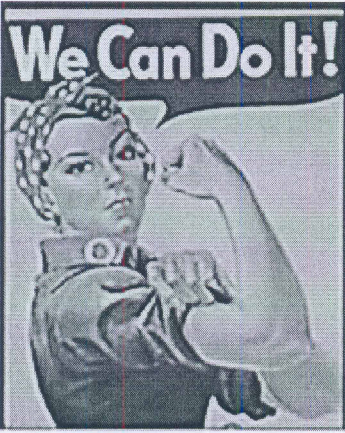
I have an idea to help with the membership drive.

Please help the Membership Committee achieve the most successful membership drive yet! Together, we can do it!



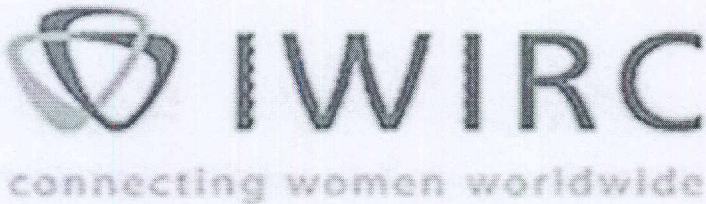
