On October 15-16, 1996, IWIRC will hold its 1996 Fall International Meeting, in connection with the United States National Conference of Bankruptcy Judges in San Diego, California, USA. Coordinator *Amy Tonti* of *Klett Lieber Rooney & Schorling* has worked hard to organize a great conference.

The program will begin Tuesday evening, October 15, 1996, with a cocktail reception, networking, and dinner. Our guest speaker will be the *Honorable Judith K. ## IWIRC IN THE INTERNATIONAL ARENA

### United Nations Commission on International Trade Law

*Selinda Melnik* and *Nancy Lazar* represented IWIRC as Official Observer at the meeting of the UNCITRAL's Working Group on Insolvency Law held on April 1-12 in New York. Since 1994, the Working Group, comprised of representatives from UN member nations, has been working to develop a legal instrument dealing with cross-border insolvency. The aim of the instrument is to facilitate judicial cooperation, court access for foreign insolvency administrators, and recognition of foreign insolvency proceedings, in cases of cross-border insolvency. IWIRC was an active participant in the 1994 INSOL/UNCITRAL meeting that initiated this project and has served as an active Observer thereafter. At the April meeting, the Working Group moved significantly towards developing a final draft document. IWIRC has been invited to serve as an Official Observer at the Working Group's next sessions in Vienna October 7 through 18, 1996 and New York in January, 1997. The goal at these meetings is to finalize the draft for consideration and adoption by the full UNCITRAL in 1997.

### International Bar Association - Committee On Insolvency & Creditors' Rights (Committee J)

The IBA will hold its next Biennial Conference in Berlin October 20-25, 1996 -- immediately following the IWIRC and NCBJ meetings in San Diego. IBA Committee J has planned an exceptional program of great interest to all IWIRC members. Several IWIRC members

will host or participate on panels throughout Committee J's three day program. ## SUCCESSFUL JOINT RETREAT BY OHIO AND TRI-STATE NETWORKS

The Ohio and Tri-State Networks held a joint retreat on April 28-29, 1996 at the Salt Fork Resort & Conference Center in Cambridge, Ohio, with over 60 bankruptcy professionals attending. The retreat began on a relaxed note with a golf outing and dinner, and continued with a seminar the following day. Speakers at the two day event included the *Honorable Marilyn Shea-Stonum*, United States Bankruptcy Judge for the Northern District of Ohio; the *Honorable Bernard Markovitz*, Chief United States Bankruptcy Judge for the Western District of Pennsylvania, and the *Honorable L. Edward Friend, II*, United States Bankruptcy Judge for the Northern District of West Virginia. Other speakers included *Michelle Laque Johnson*, Managing Editor of *Bankruptcy Court Decisions*, discussing marketing and the media; a panel discussion by bank counsel regarding hiring outside counsel; and a discussion by *Randi Starr* of *Deloitte & Touche*, regarding efforts to expand women in management opportunities. The event was considered a great success by both chapters. Plans are underway to make this an annual event.

## THE LOCAL NETWORKS

### Australia Network

Since receiving their charter in December 1995, the Australia Network has established a Network committee to serve as an umbrella organization for semi-autonomous state groups. Three Australian states currently have IWIRC groups in operation: Queensland, New South Wales and Victoria. The Australia Network is working on establishing IWIRC groups in the other states and hopes to have South Australia "on board" in the near future and Western Australia within a few months.

The initial Australia Network function was held in May, 1996 in conjunction with the 1996 Bankruptcy Congress. The evening included a lively, and sometimes cynical, debate on "Should We Have a Debtor's Prison", followed by cocktails, and was held in the Police and Justice Museum -- a most appropriate venue. The next event will be in October, 1996 when, at the invitation of the Australian Institute of Credit Management, IWIRC will present a Role Play at the Institute's 1996 National Conference. This Role Play will demonstrate the legal issues and

proceedings associated with a defended debt recovery action.

In addition to the events of the umbrella Australia Network, each of the state groups has been active. New South Wales continues a program of regular breakfasts and luncheons with guest speakers.

The Queensland Branch held its 1996 public function in July in Brisbane with guest speakers including *Professor Jim O'Donovan*, Professor at Law at the *University of Western Australia* and specialist consultant to KPMG. The event was a great success with over 100 attendees and resulted in a number of new members.

The Victoria Branch meets regularly on the first Tuesday of each month for drinks and networking. In addition, the branch recently held a successful event -- a quiz night on the topic "Battle of the Sexes." The program consisted of two panels, one of women and the other of men, with each panel comprised of a banker, accountant and solicitor representative. Held at the Stock Exchange theater, more than 80 professionals attended the event.

*Maree Henry*, liaison for the Australia Network, reports that in the last 12 months, the profile of IWIRC in Australia has increased significantly, and there is now a recognition within the insolvency and reconstruction sector, as well as associated areas, that IWIRC is a professional and credible organization which is not going to "disappear overnight".
