The IWIRC - Atlantic Canada Network has a four member board. A list of the Board of Directors is attached.


The IWIRC – Atlantic Canada Network is in its infancy stages. Currently there are 5 members of the network. This chapter currently has limited activity due to low enrollment and competing interests for events. The yearly cost of enrollment seems to be limiting the number of members for our small insolvency community. It is suggested that IWIRC review the required enrollment fees for small centers.

The IWIRC - Atlantic Canada Network held 4 board meetings in 2016. The chapter was founded in early 2015. As a result, no board elections have taken place. It is expected that a board election will take place in 2017.

The Atlantic chapter held 1 event this year. It was a charity event/board meeting in which members prepared shoeboxes for women who are homeless or at-risk of homelessness in Halifax. Approximately 6 non-members attended the event.
